Liquor Stores Income Fund Announces October Cash Distribution

EDMONTON, Alberta, October 15, 2009 – Liquor Stores Income Fund (the "Fund") (TSX:"LIQ.UN") announced today a cash distribution of \$0.135 per trust unit for the month of October 2009. The distribution will be paid on November 13, 2009, to holders of record of trust units on October 30, 2009.

The Fund's policy is to pay cash distributions on or about the 15th of each month to unitholders of record on the last business day of the preceding month.
